I. General Provisions

1.1. The purpose of the state final certification is to establish the level of preparation of the graduate to perform professional tasks and the compliance of his/her preparation with the requirements of the Federal State Educational Standard of Higher Education and the basic educational program of higher education (hereinafter referred to as the OPEP VO), developed at Bunin Yelets State University.

The procedure for conducting the state final certification is set out in the Regulation on the procedure for conducting the state final certification for the basic professional educational programs of higher education - bachelor's degree programs, specialist programs, master's degree programs of the Federal State Budgetary Educational Institution of Higher Education "Bunin Yelets State University".

1.2. The final state certification in the direction of training 44.03.01 Pedagogical Education programme Fine Arts includes the completion and defense of the final qualification work (hereinafter referred to as the FQW).

1.3. In the course of mastering the OOP VO, the graduate prepares for professional activity in the field of 01 Education and Science (in the field of pre-school, primary general, basic general, secondary general education, vocational training, vocational education, additional education).

1.4. A graduate who has mastered the bachelor's degree program is ready to solve the problems of professional activity of the following types: pedagogical, methodological.

Tasks of professional activity of graduates:

pedagogical:

- implementation of professional activity in accordance with regulatory and legal acts in the field of education and standards of professional ethics;
- implementation of joint educational and upbringing activities of students in accordance with the requirements of federal state educational standards;
- spiritual and moral education of students in educational activities;
- implementation of educational activities based on special scientific knowledge, including in the subject area;
- spiritual and moral education of students in extracurricular activities;
- monitoring and evaluation of the formation of educational results of students.

methodical:

- development and implementation of educational programs in the field of general education, secondary general education and additional education;
- individualization of training, development, education, including students with special educational needs, with the help of psychological and pedagogical technologies in professional activity.

1.5. The volume of the state final certification is: 9 credit units.

1.6. The FQP is aimed at checking the development of students' universal, general professional and professional competencies, correlated with the established OPEP HE, indicators of competency achievement: UC-1; UC-2; UC-3; UC-4; UC-5; UC-6; UC-7; UC-8; UC-9; UC-10; GPC-1; GPC-2; GPC-3; GPC-4; GPC-5; GPC-6; GPC-7; GPC-8; GPC-9; PCS-1; PCS-2.

II. Forms of state final certification

Graduation qualification work

Completion and defense of the final qualification work is the final stage in mastering the basic educational program. The final qualification work can be based on the generalization of previously completed coursework and research papers and other works (final qualification works of other educational levels, in the absence of mechanical transfer of paragraphs), contain materials collected, analyzed and summarized by students during the period of educational and industrial practices.

The purpose of the final qualification work: systematization and deepening of theoretical and practical knowledge and competencies, in the direction of training 44.03.01 Pedagogical Education programme Fine Arts, consolidation of skills of independent research activities. The final qualification work should testify to the degree of readiness of the graduate for professional activity.

The structure of the final qualifying work is determined by the Regulation on the procedure for conducting state final certification for the basic professional educational programs of higher education - bachelor's degree programs, specialist degree programs, master's degree programs of the Federal State Budgetary Educational Institution of Higher Education "Bunin Yelets State University" and includes:

- table of contents;
- introduction, including the relevance of the research problem, the purpose, objectives, object and subject of the research; theoretical and practical significance of the research conducted and the results obtained;
- main part, the structure and content of which depend on the nature and features of the final qualifying work;
- conclusion;
- list of references;
- appendices.

The content and design of the final qualifying work are regulated by the Regulation on the procedure and form of conducting state final certification for the basic professional educational programs of higher education - bachelor's degree programs, specialist programs, master's degree programs of the Federal State Budgetary Educational Institution of Higher Education "Bunin Yelets State University".

The recommended volume of the final qualifying work is at least 40-50 pages of the main text.

The text of the final qualifying work should include materials illustrating the content of the work (tables, graphs, figures, drawings, diagrams, etc.).

The level of originality of the text of the final qualifying work should be at least 50% (including citations).

In addition to the standard requirements for the procedure for defending a final qualifying work (clause 2.19 of the Regulation on the procedure and form of conducting state final certification for the basic professional educational programs of higher education - bachelor's degree programs, specialist programs, master's degree programs of the Federal

State Budgetary Educational Institution of Higher Education "Bunin Yelets State University"), there is a requirement for visualizing the practical results of the research: an accompanying presentation (no less than 10 slides), a slide show or a video clip.

The assessment materials for the final qualifying work are a list of topics for final qualifying works, annually approved by order. The topics of final qualifying works are relevant and correspond to the current state and prospects for the development of science, as well as the objectives of the academic disciplines and practices of the Basic Educational Standards in the direction of training 44.03.01 Pedagogical Education programme Fine Arts.

Sample topics for the final qualifying work:

1. Fine arts and digital technologies in a modern school.
2. Project activities in fine arts lessons in primary school.
3. Development of compositional thinking of schoolchildren in fine arts classes.
4. Master class in fine arts as an innovative form of activating the creative abilities of students.
5. Formation of aesthetic culture of students based on the study of the history of fine arts.
6. Methodological features of organizing a children's fine arts studio.
7. Using images of folk art in the visual arts of students.
8. Innovative methods of art education.
9. Development of cognitive activity of schoolchildren in visual arts classes.
10. Didactic support for the work of schoolchildren in visual arts classes.
11. Methods for developing motivation for artistic activity in schoolchildren.
12. Interdisciplinary connections and the nature of their interaction in the process of teaching visual arts.
13. Meta-subject approach to teaching visual arts at school.
14. Designing a program of classes in visual arts based on regional traditions.
15. Methods of individualization of student learning in visual arts classes.
16. Pedagogical techniques for organizing collective activities of schoolchildren in visual arts classes.
17. Development of spatial thinking in schoolchildren in visual arts classes.
18. The role of colorists in developing the creative imagination of schoolchildren.
19. Methodological principles for organizing visual arts activities of students in the open air.
20. Criteria for assessing students' knowledge, skills and abilities in the field of fine arts.

Methodological materials for assessing the final qualifying work are presented in the assessment and methodological materials for the direction of training 44.03.01 Pedagogical Education programme Fine Arts, developed on the basis of the Regulation on assessment and methodological materials for the basic professional educational programs of higher education - bachelor's degree programs, specialist programs, master's degree programs of the Federal State Budgetary Educational Institution of Higher Education "Bunin Yelets State University". The methodological materials, among other things, include criteria for assessing the final qualifying work.
