### **III. EVALUATION MATERIALS FOR CONDUCTING CURRENT AND INTERIM CERTIFICATION OF STUDENTS IN THE DISCIPLINE**

Current certification is conducted in the form of a test (performance of a concert program).

#### **A typical version of the test tasks**

1. In accordance with Federal Law No. 35-FZ dated 06.03.2006 "On countering Terrorism", terrorism is –

1. The ideology of violence and the practice of influencing decision-making by state authorities, local governments or international organizations related to intimidation of the population and (or) other forms of illegal violent actions;
  2. Dangerous crimes against the foundations of public administration and social society;
  3. Creation of a stable armed group (gang);
  4. A form of radical denial of the existing generally recognized social norms and rules in the state.
2. The President of the Russian Federation in the field of countering terrorism:
    1. Determines the competence of the federal executive authorities, whose activities he directs, in the field of countering terrorism;
    2. Organizes the development and implementation of measures to prevent terrorism and minimize and (or) eliminate the consequences of manifestations of terrorism;
    3. Organizes the provision of the activities of federal executive authorities, executive authorities of the subjects of the Russian Federation and local self-government bodies to counter terrorism with the necessary forces, means and resources;
    4. Defines the main directions of state policy in the field of countering terrorism.
  3. The Government of the Russian Federation in the field of counter-terrorism:
    1. Establishes the procedure for interaction between federal executive authorities, state authorities of the subjects of the Russian Federation and local self-government bodies, individuals and legal entities when verifying information about the threat of committing a terrorist act, as well as informing counter-terrorism entities about the identified threat of committing a terrorist act;
    2. Establishes the competence of the federal executive authorities, whose activities it directs, to combat terrorism;
    3. Decides in accordance with the established procedure on the use of formations of the Armed Forces of the Russian Federation outside the territory of the Russian Federation;
    4. Defines the main directions of state policy in the field of countering terrorism;
  4. Formations of the Armed Forces of the Russian Federation are involved in conducting a counter-terrorism operation to resolve:
    1. The Ministry of Defense of the Russian Federation;
    2. The Government of the Russian Federation;
    3. The President of the Russian Federation is in order;
    4. The Main Directorate for Countering Extremism of the Ministry of Internal Affairs of the Russian Federation (GUPE of the Ministry of Internal Affairs of Russia).
    5. The legal regime of the counter-terrorism operation:
      1. It is introduced for conducting information and propaganda events in municipalities to explain the essence of terrorism and its public danger;
      2. It is introduced to provide medical and other assistance to persons injured as a result of a terrorist act;
      3. The Government of the Russian Federation is introduced to ensure the activities of formations of the Armed Forces of the Russian Federation;
      4. It is introduced in order to prevent and disclose a terrorist act, minimize its consequences and protect the vital interests of the individual, society and the state.
    6. The head of the counter-terrorism operation:
      1. Determines the structure and working procedure of the operational headquarters for the period of the counter-terrorism operation, as well as the tasks and functions of officials included in the operational headquarters;
      2. Organizes the development and implementation of measures, as well as state programs of the subject of the Russian Federation in the field of terrorism prevention, minimization and elimination of the consequences of its manifestations;
      3. Carries out interregional cooperation in order to study the issues of terrorism prevention, minimization and elimination of the consequences of its manifestations;

4. Participates in the social rehabilitation of persons injured as a result of a terrorist act committed on the territory of a constituent entity of the Russian Federation.

7. Who decides on the use of weapons by the Armed Forces of the Russian Federation from the territory of the Russian Federation against terrorists located outside its borders and (or) their bases:

1. The Ministry of Defense of the Russian Federation;
2. The President of the Russian Federation;
3. The Government of the Russian Federation;
4. The head of the counter-terrorism operation.

8. The total number of formations of the Armed Forces of the Russian Federation, their areas of operation, their tasks, and the duration of their stay outside the territory of the Russian Federation are determined:

1. The President of the Russian Federation;
  2. The Main Directorate for Countering Extremism;
  3. The Government of the Russian Federation;
  4. The State Duma of the Russian Federation.
9. Political demands made by terrorists during negotiations...
